INTRODUCTION 简介

The Marks & Spencer ECP Self-Audit must be **completed** and **submitted every 18 months** by all Finishing Tanneries supplying Marks & Spencer with leather.

所有向玛莎百货供应皮革的制革厂都必须每 **18 个月完成并提交**玛莎百货的 ECP 自我审核报告。

This self-audit document reflects the structure and layout of the 4 preceding modules of the ECP (MRSL/RSL, REACH, Minimum Standards & Best Practices, environmental management). These modules provide information regarding each section of the self-audit document. Please ensure you and your suppliers have read and understand these ECO modules before proceeding. All questions must be answered to ensure the audit accurately represents your facility. In the event of non-compliance, Marks & Spencer reserve the right to cancel orders and return products.

ECP ASSESSMENT PROCESS ECP 评估步骤

Each tannery will need to be proposed to Marks & Spencer UK by either a Marks & Spencer Technologist or a Primary Supplier (the PROPOSER). The proposer must complete the ECP self-audit on line via the link (<https://supplierexchange1.marksandspencer.com/ECP>)

The self-audit will be assessed by the proposer and Marks & Spencer UK/Sourcing office. If the audit is approved the Tannery will be issued with a unique Marks & Spencer ECP reference number. The ECP number is valid for 18 months, after which a new audit must be completed online. You will receive a reminder to complete the audit before the 18 month period expires.

Please note that the completed audits will be used by Marks & Spencer technologists during factory visits to assess on-going compliance to ECP. There will also be a Due Diligence programme in place to ensure that self-audit results are a true and accurate statement of the conditions in the factory. This will consist of a random selection of facilities being audited by Marks & Spencer or a 3rd party.

The Institute of Public and Environmental Affairs (IPE) is a registered non-profit organization based in Beijing. Since its establishment in May 2006, IPE has developed a pollution database to monitor environmental performance across several industry sectors – including textiles. IPE's aim is to expand environmental information disclosure to allow communities to fully understand the hazards and risks in the surrounding environment, thus promoting widespread public participation in environmental governance.

公众与环境研究中心（IPE）是一个注册的非营利性组织，总部设在北京。2006年5月成立以来，IPE已经开发了一个横跨多个行业（包括纺织品）的污染数据库，以此来监控环境绩效。IPE的目的是扩大环境信息披露，使社区完全理解周围环境的危害和风险，促使广大公众参与环境治理。

M&S has already been using the IPE website as a useful screening tool to ensure ECP applications are highlighting any previous pollution violations. **M&S is now making public disclosure of PRTR on IPE website a mandatory requirement of the ECP approval process.**

What is PRTR platform in IPE? 什么是 IPE 里的 PRTR 平台？

The full name of PRTR is 'Pollutant Release and Transfer Register' and they are broadly defined as systems or platforms to collect and disseminate information on environmental releases and transfers of toxic chemicals from industrial and other facilities.

PRTR的全名是“污染物排放和转移登记”，广义上说，这是一个信息收集和传播的系统或平台，以监管来自工业和其他设施的有毒化学物质的排放和转移。

PRTR on the IPE website consists of an Excel spreadsheet that facilities complete, and includes details such as supplier background details, pollutants, resource consumption and recycling management data.

IPE 网站上的 PRTR 包含一个 Excel 电子表格，需由工厂填写，其中包含了很多细节信息，如供应商的详细背景、污染物、资源消耗和回收管理的数据。

As part of its ongoing commitment to greater supply chain transparency and responsible manufacturing M&S is now making PRTR disclosure on IPE's website a mandatory requirement of the ECP approval process. This addition to the ECP submission process takes place with immediate effect for Chinese wet processing facilities only.

If you are M&S partner involved in wet processing, you are now required to disclose pollution data information from your own facility, or outsourced facility, via the PRTR

Once completed, IPE will conduct desktop data audit to check disclosed data in PRTR against testing report evidence. After data validation, IPE will approve and post the PRTR form to platform.

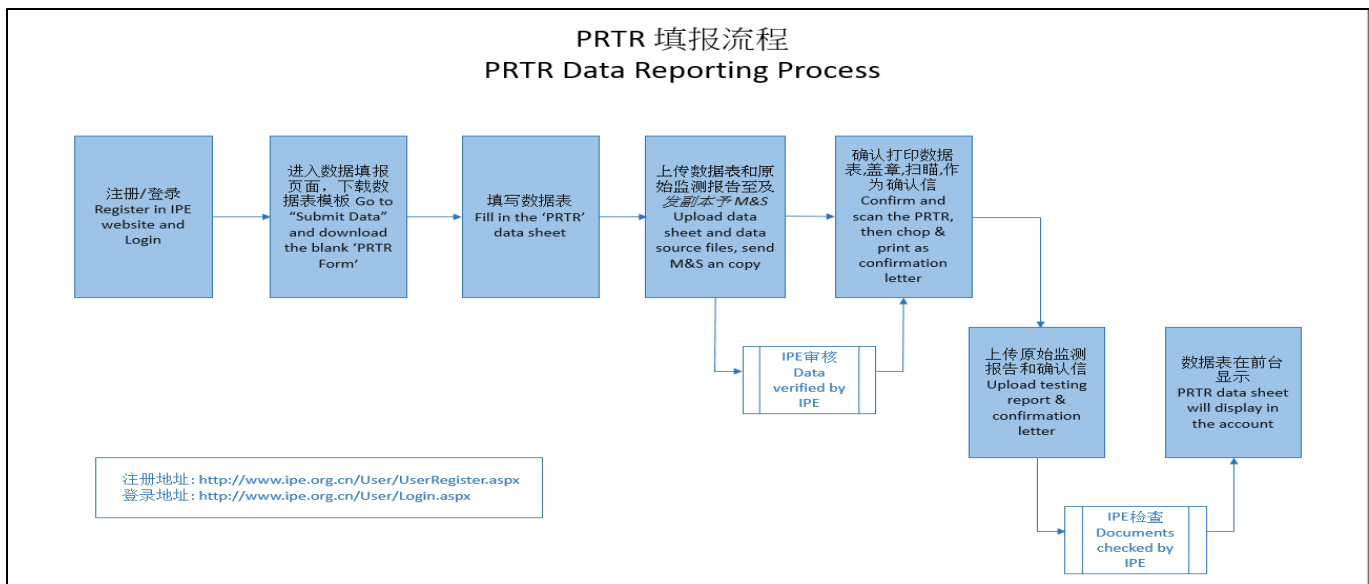

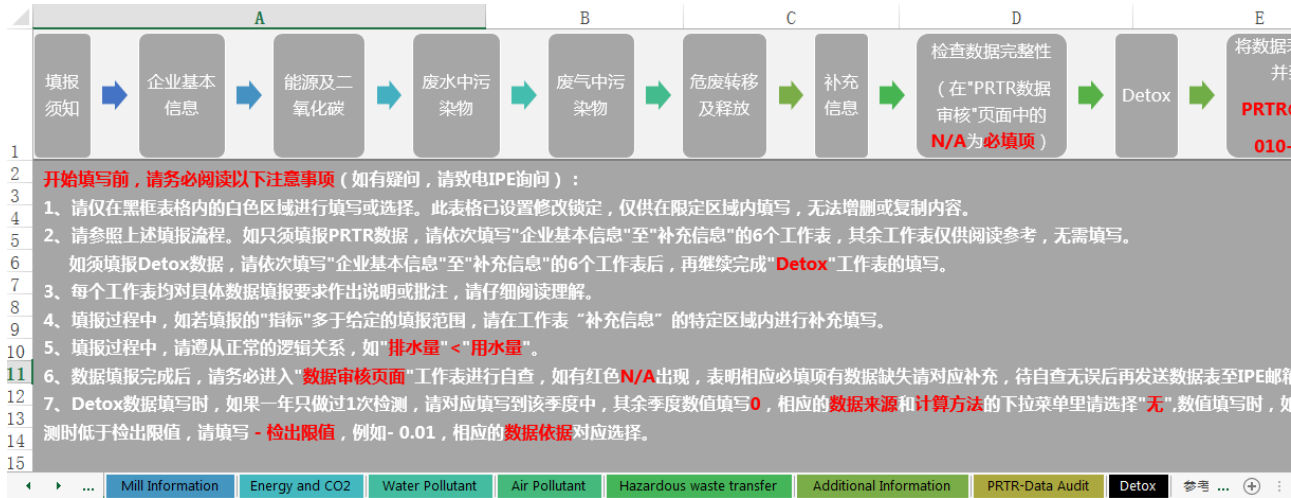
Process of PRTR Data Reporting PRTR 数据报告的过程
